

PRIVACY NOTICE INSURANCE PRODUCERS

As an individual appointed with or seeking appointment with Allianz Life Insurance Company of North America (Allianz) as an insurance producer, or an individual appointed with Allianz as a servicing agent (collectively, "insurance producer"), you have the right to know what categories of Personal Information Allianz collects about you and the purposes for which such information is collected.

As used in this Privacy Notice, "Personal Information" means information that identifies, relates to, describes, is reasonably capable of being associated with, or could reasonably be linked, directly or indirectly, to you or your household. Personal Information includes, but is not limited to, the categories identified below if such information identifies, relates to, describes, is reasonably capable of being associated with, or could be reasonably linked, directly or indirectly, with you or your household.

If you are an insurance producer who resides in California, this Privacy Notice is intended to comply with the California Consumer Privacy Act of 2018 and any subsequent amendments (collectively, "CCPA"). Allianz collects this information on behalf of itself, and, as applicable to your appointment, Allianz Life Insurance Company of New York and Allianz Life Financial Services, LLC.

This Privacy Notice is effective February 6, 2026.

CATEGORIES OF PERSONAL INFORMATION WE COLLECT AND OUR BUSINESS PURPOSE FOR PROCESSING THAT INFORMATION

We collect the following categories of Personal Information for the purposes described below, as permitted by applicable law. These categories are defined by California law and represent the Personal Information that we may have collected about California residents, and how it may have been shared, over the past 12 months. Our business purposes for processing your information are provided below the chart. The inclusion of a category in the list below indicates only that we may collect this information for certain individuals for some activities within the scope of the identified business purpose. It does not necessarily mean that we collect all the information listed in a particular category for all individuals appointed or seeking appointment.

We have shared information in each category with our affiliates and service providers for our business purposes within the last 12 months. As an insurance company, we may also receive requests for information from regulatory authorities, our auditors, and/or our legal advisors. If requested from such parties, we would share your Personal Information as appropriate.

Personal Identifiers	Real name, alias, date of birth, postal address, telephone number, unique personal identifiers (including your national producer number), online identifier, internet protocol (IP) address, email address, Social Security number, driver's license or state identification card number, passport number, visa information, written signature, insurance policy number, or other similar identifiers.
Demographic Identifiers and Other Information	Demographic information protected under federal law, California law or other state law, including age, sex, gender, sexual orientation, racial or ethnic origin, national origin, citizenship or immigration status, residency or work permit status, marital status, health and disability status or military/veteran status as well as aggregated demographic information such as census data block groups.
Employment Information	Employment history, professional licensures, salary information, professional or employment-related information, including written signatures, and other information collected from a resume or application.
Education	Education history including educational institutions attended, degree(s) and/or certification(s) earned, and other information collected from a resume or application.
Financial Information	Bank account number, credit card or debit card number, or any other financial information.
Internet or other Electronic Network Activity	Information about our website's usage, user interactions, and visitor behavior as well as online identifiers, internet protocol (IP) address, and information regarding an individual's interaction with our website including page visits, browsing or search history, including when browsing anonymously, or an individual's device interaction with an internet website application or advertisement as described in our Online Privacy Policy .
Profile Information	Inferences drawn from any of the information listed above, including creating a profile about you reflecting your preferences, characteristics, psychological trends, predispositions, behavior, attitudes, intelligence, abilities, and aptitudes.
Audio/Visual Information	Audio call recordings of customer service calls, which may be transcribed using AI technology. We may also use AI technology during meetings to transcribe meeting content and notes. We use photos for security and access purposes and utilize on-site cameras to record video and to monitor activities within the premises.

PURPOSES FOR WHICH WE MAY COLLECT AND SHARE PERSONAL INFORMATION

- Evaluate a potential insurance producer relationship with you and contact you regarding your request for an insurance producer appointment with us.
- Perform background checks and verify your professional standing and qualifications, including your insurance licenses.
- To comply with anti-discrimination laws and government reporting obligations to help ensure equal employment opportunities, and for internal reporting purposes.
- To evaluate, determine, and arrange compensation.
- For purposes such as paying commissions, we may collect financial information, including bank account number.
- As needed to support the Insurance Producer relationship, including authorization, acceptance, agreement, etc., to terms of your appointment as an Allianz producer, or for related purposes.
- We may use generative artificial intelligence, predictive models, machine learning, agentic automation, and advance analytics tools subject to appropriate human oversight, including external consumer data and information sources in compliance with applicable laws and regulations, to better understand and support our producers, provide relevant information, and to prioritize sales calls.
- To review and respond to requests for customer service where a customer references a relationship with you.
- For quality assurance, training, operational efficiency, user authentication, enhancing sales and service workflows and accuracy of documentation, and facilitating information sharing.
- To discuss applications, sales, and process and administer the policies you submit for issue by the company.
- For the clearing and settlement of insurance transactions.
- To assist in servicing existing business and to contact you to discuss Allianz products and services that may be of interest to you.
- To provide relevant marketing such as prospect marketing, direct marketing, and satisfaction surveys to gather feedback.
- Supporting the technical research, development, improvement, and administration of Allianz Life web properties, including Allianzlife.com, the Allianz Career Website, and the Recruiting system.
- To improve user experiences by analyzing site metrics such as search terms, page views, and time spent to ensure accurate search results and personalized content.

- To perform data and demographic analysis, and to use data analytics and insights to develop and improve our website, products, and services and to provide you with information that is relevant to you.
- To improve operational processing time, customer and financial professional experiences, or to flag anomalies for compliance purposes.
- To enable required regulatory training.
- To obtain identity and digital footprint identifiers to improve security and detect and prevent against malicious, deceptive, fraudulent, or illegal activity.
- For physical access and monitoring access to our locations, we may require a photograph and badge.

In addition to the purposes identified above, Allianz may use and disclose Personal Information that we collect as necessary or appropriate to:

- Comply with laws and regulations, including (without limitation) applicable tax and insurance laws and regulations.
- Ensure compliance with and adherence to Allianz policies, procedures, and regulatory compliance, while investigating and addressing any potential breaches.
- Comply with civil, criminal, judicial, or regulatory inquiries, investigations, subpoenas, or summons.
- Exercise or defend the legal rights of Allianz and its employees, affiliates, customers, contractors, agents, and producers.

SOURCES OF PERSONAL INFORMATION

- Directly from you.
- Recruiters.
- Wholesalers such as Broker Dealers and Field Marketing Organizations.
- Prior employers and professional references.
- Educational institutions.
- Pre-employment screening and background check services.
- Regulatory agencies and credentialing and licensing organizations.
- Research or analytics companies and Discovery Data.
- Market metrics.
- Publicly available sources, such as social media profiles on LinkedIn, X, or Facebook, and aggregate information such as census data block groups.
- Clearing and settlement organizations.
- From a party requesting customer service.
- Indirectly from you or your interaction with our website including page visits, browsing or search history, including when browsing anonymously, as described in our [Online Privacy Policy](#), and your interaction with our technology, security devices and software.
- Other sources as directed by you.

CATEGORIES OF SENSITIVE PERSONAL INFORMATION COLLECTED

We also collect the following categories of Sensitive Personal Information. We generally use Sensitive Personal Information only for the necessary purposes listed below.

Biometric Information	We may create a voiceprint for authentication, security, and fraud prevention purposes.

PURPOSES FOR WHICH WE COLLECT AND SHARE SENSITIVE PERSONAL INFORMATION

Below are the reasons for which we may collect Sensitive Personal Information about you:

- Perform background checks and verify past employment, educational history, and professional standing and qualifications.
- To comply with anti-discrimination laws and government reporting obligations, to help ensure equal employment opportunities and for internal reporting purposes.
- To use identity and digital identifiers to improve security, authenticate your identity, and verify your access permissions to Allianz websites, systems, networks, databases, devices, equipment, and facilities.
- To detect, investigate, and help protect against malicious, deceptive, fraudulent, or illegal activity.
- To exercise or defend the legal rights of Allianz and its employees, affiliates, customers, contractors, agents, and producers.
- As required by applicable local and federal laws.

SOURCES OF SENSITIVE PERSONAL INFORMATION

When we receive Sensitive Personal Information, we receive it from the following sources:

- Directly from you.
- From your calls to or from recorded lines.
- From educational institutions.
- From credentialing and licensing organizations.
- From screening and/or background check services.
- From other sources as directed by you.

We will not collect additional categories of Personal Information or use the Personal Information we collected for materially different, unrelated, or incompatible purposes without providing you notice.

DISCLOSURE OF PERSONAL INFORMATION AND SENSITIVE PERSONAL INFORMATION

We may disclose your Personal Information or Sensitive Personal Information to third-party service providers for business purposes. When we disclose Personal Information for a business purpose, we enter into a contract that describes that purpose and requires the recipient to keep the Personal Information confidential, and not to use it for any purpose other than performing the contract. We may transfer your information to another country for processing as permitted and in compliance with applicable law. We do not sell your Personal Information to third parties, and we do not share your information for cross-context behavioral advertising purposes, as defined under California law. We may share your Personal Information or Sensitive Personal Information for the business purposes described in this Insurance Producer Privacy Notice with the following parties:

Corporate Affiliates	We may share your information with our corporate affiliates and with their respective officers, directors, employees, accountants, attorneys, and agents.
Acquisitions and Similar Transactions	If the company is sold or part of its assets are merged with another company, your personal data may be transferred as part of the merger or sale.
Disclosures with Your Consent	We may ask if you would like us to share your information with other unaffiliated third parties not described elsewhere in this Policy. We will only disclose your information in this context with your consent.
Legal Obligations and Rights (Subpoenas, Court Orders, and Warrants); Regulatory Authorities	We may disclose information to comply with the law, including disclosure to relevant industry regulatory bodies, or in response to subpoenas, warrants, court orders, or other legal process.
Service Providers	We may share Personal Information with our third-party service providers that need access to information to help us support our relationship with you, provide operational or other support services on our behalf for security purposes, to authenticate users and prevent, detect, and investigate deceptive, fraudulent, or illegal acts. Service Providers may include vendors providing software, platforms, or tools (including machine learning, generative AI, agentic automation, advanced analytics, or biometric tools) or provide website tracking technologies such as cookies, tags, or pixels that use anonymous browsing information or Personal Information as described in our Online Privacy Policy .
Professional Advisors (Auditors and Legal Advisors)	We may share your information with our professional advisors, including attorneys, auditors, and accountants, to provide services on our behalf.
De-identified or Aggregated Data	We may disclose aggregated information or de-identified information about our users that does not identify any specific individual including through web tracking technologies.
Other	Where required or permitted by law.

PERSONAL DATA STORAGE AND RETENTION

We and our service providers store Personal Information on computer systems. We keep records containing Personal Information in accordance with applicable state and federal regulations or contractual obligations. We aim to retain Personal Information only for as long as necessary for the purposes it was collected for, including defending or advancing legal claims, and complying with legal obligations. We may need to keep some Personal Information for longer than other information to comply with applicable laws and regulations, including litigation.

When determining how long to retain a record, including any Personal Information it contains, we consider the following criteria:

- The length of time the record is needed to provide the products and services you request and maintain our business relationship.
- The length of time the record is needed to support and improve our operational processes.
- The length of time the record is needed to protect our rights and legal interests.
- The length of time the record must be kept to comply with applicable laws and regulations.

The same Personal Information about you may be included in more than one record and used for more than one purpose, each of which may be subject to different retention periods based on the factors listed above.

We may delete Personal Information if we believe it is incomplete, inaccurate, or that our continued storage of it is contrary to our objectives or legal obligations. When we delete data, we remove it from our active servers and databases, but it may remain in our archives when it is not practical or possible to delete it.

To the extent permitted by law, we may retain and use anonymized, de-identified, or aggregated information for performance reporting, benchmarking, and analytic purposes and for product and service improvement.

YOUR PRIVACY RIGHTS

If you are a California resident, California law provides you with specific rights regarding your Personal Information, subject to certain limitations. This section describes these rights and explains how to exercise those rights if they apply to you.

1. Right to Access Your Data. You have the right to request that we disclose certain information to you about our collection and use of your Personal Information. Once we receive and confirm your verifiable consumer request, you have the right to receive:

- The categories of Personal Information we collected about you.
- The categories of sources for the Personal Information we collected about you.
- Our business or commercial purpose for collecting, selling or sharing that Personal Information.
- The specific pieces of Personal Information we collected about you, including by a service provider or contractor.
- The categories of third parties with whom we share that Personal Information.
- The specific pieces of Personal Information we have disclosed for a business or commercial purpose, identifying the personal information categories that each category of recipient obtained about you.

Any disclosures we provide will only cover the 12-month period preceding receipt of your request. The response we provide will also explain the reasons we cannot comply with a request, if applicable.

2. Right to Data Portability. You have the right to a “portable” copy of your Personal Information that you have submitted to us. Generally, this means you have a right to request that we move, copy, or transmit your Personal Information stored on our servers / IT environment to another service provider’s servers / IT environment.

3. Right to Correction. You have the right to request correction or changes to your Personal Information if it is inaccurate or out of date.

4. Right to Delete Your Data. You have the right to request that we delete any of your Personal Information that we collected from you and retained, subject to certain exceptions. Once we receive and confirm your verifiable consumer request, we will delete (and direct our service providers to delete) your Personal Information from our records, unless an exception applies.

5. Right to Opt Out of Sale or Sharing of Personal Information. We currently do not sell Personal Information to third parties or share Personal Information about insurance producers with third parties for cross-context behavioral advertising purposes, and therefore do not offer this option. We may disclose Personal Information about you to our affiliates and service providers as permitted by law. Please see the “Sharing Personal Information” portion of this policy for more information.

6. Right to Limit Use and Disclosure of Sensitive Personal Information. You have the right to request we limit the use of your Sensitive Personal Information to only purposes necessary to engage with you as an insurance producer. California law defines this Sensitive Personal Information, and you can find a more detailed description of the types of information in the charts included above. We only use your Sensitive Personal Information for necessary purposes such as to engage with you as an insurance producer, to aid in protecting and securing your Personal Information and our systems, to verify or maintain the quality or safety of our services and systems, or as otherwise permitted under regulations or required by law.

7. Right to Non-Retaliation. We will not retaliate against you for exercising any of your privacy rights.

To exercise your rights, you, or an agent authorized to request information on your behalf, must submit a verifiable consumer request using one of the methods listed below:

AUTHORIZED AGENT

If you would like to appoint an authorized agent to make a request on your behalf, you must provide the agent with written, signed permission to submit privacy right requests, on your behalf, or provide a letter from your attorney. The agent or attorney must provide this authorization at the time of the request. We may require you to verify your identity with us directly before we provide any requested information to your authorized agent.

VERIFICATION

For your privacy and security, we may take steps to verify your identity before fulfilling your request. For example, we may collect information from you, including, to the extent applicable, your name, government identification number, date of birth, contact information, your account information, answers to security questions, or other personal identifying information. We will verify your identity and respond to your request by matching the information you provide with information we have previously collected about you. The information collected for verification purposes will be used solely for that purpose. If you have an account with us, you may be asked to log in to your account when submitting your request.

If we are unable to verify your identity as part of your request, or if there is another exception, we will not be able to satisfy your request. In some instances, such as a request to delete Personal Information, we may first separately confirm that you made the request for us to delete your Personal Information before acting on your request subject to data retention periods.

RESPONSE TIMING AND FORMAT

If you are entitled to any of the above-described rights, we endeavor to respond to a verifiable request within forty-five (45) days of its receipt. If we require more time (up to 90 days), we will inform you of the reason and extension period in writing.

We will deliver our written response by mail or electronically, at your option.

Any disclosures we provide will cover the 12-month period preceding receipt of a verifiable request; however, you may have the right to request access to Personal Information that is more than 12 months old. The response we provide will also explain the reasons we cannot comply with a request, if applicable. For data portability requests, we will select a format to provide your Personal Information that is readily useable and should allow you to transmit from one entity to another entity without hindrance.

We do not charge a fee to process or respond to your verifiable request unless it is excessive, repetitive, or manifestly unfounded. If we determine that the request warrants a fee, we will tell you why we made that decision and provide you with a cost estimate before completing your request.

CHANGES TO OUR PRIVACY NOTICE

We reserve the right to change this Privacy Notice at any time in our sole discretion. If we make changes, we will post the revised Privacy Notice on our website so that you can see what information we gather, how we might use that information, and in what circumstances we may disclose it. If you continue to engage with us after receiving notice, you accept and agree to the modified Privacy Notice.
